This is an ongoing is which has been noted in the minutes since 2017.

Fraud email sent from Chair of the Board to members of the board requesting funds. Board Chair to contact Halifax Regional Police to report cyber fraud attempt.

Question brought forward about board laptops and the lack of anti virus protection. Chair to inquire on this matter and also check protection on FFFNS computer systems. -Overdue Performance Review

Put on hold due to ED being on medical leave. Board Chair to locate board file cabinet and performance review documents and bring them to the next board meeting for review. -Staff Refreshments

Refreshments that were purchased for the staff we paid for out of pocket by the Board Chair. Board is requesting Comptroller reimburse for this as per board vote at the board meeting in Port Hawkesbury where the ED notified the Board that there were funds available for this expenditure.

Going forward only the ED will bring requests regarding staff to the Board for approval these requests will be looked at on an individual basis.

Communicated that foster parents and perspective foster parents are waiting a month for a call back with information. Board is requesting the development of an excel spreed sheet too track regions so that timely followup can be achieved, also for justification of the expense of the 1-800 number.

-Interm ED

In the absence of the Executive Director medical leave the board has decided to propose that the current Allegation Support Worker become the intern ED

-In Camera Sessions

FFFNS Board of Directors has decided that if a director is not in attendance for an in camera session that the information shared in that session cannot be shared as this would be a breech of confidentiality

-Bursary Committee

Committee needs to follow up with one applicant. DK(Mikmaq) reviewed all applicants and the committee will distribute funds to applicants in September after confirmation of attendance is established.

-Work from home

working from home will be following a directive from public health (state of emergency)in coordination with the ED. If this situation arrises the FFFNS Board should be made aware by the ED. Any other working from home would be in extenuating circumstances and need ED and Board approval for such.

-HR Policy

Legal Council has been very adamant that the FFFNS Board of Directors not accept or implement the draft HR policy that was developed by Savory Consultants. He does not feel this policy has any merit and would be harmful for the FFFNS. Legal Council recommends that the FFFNS continue to use the current HR policy. The HR Committee will review the current policy and bring any recommendations to the FFFNS Board of Directors for review.
