NEW BUSINESS

- Board meeting structure Board chair meet for quarterly budget meeting with OSD and had discussions around the board meeting budget. OSD is requesting in the draft service agreement that we meet 6 times a year. Looked at what is a realistic board budget request and had discussion around examining areas for cost savings. Some ideas were:
 - Using of the federation board room for meetings
 - Meet and greets do we host these on Friday evenings or would virtual work better?
 - Committee work looking if virtual would work verses in person.
- Governance training Training that was scheduled for March was postponed due to being over the allotted board meeting budget for the fiscal year and now meeting virtually as a result. Had discussions around a new date, time and location, and if before or after the AGM.
- April board meeting location was changed to the Federation Board room. Hotel rooms will be provided for members outside of HRM. We will examine these cost savings and compare to other meetings.
- Did you know e-mail will be sent out by the office by e-mail to foster caregivers on behalf of board representatives from each region that highlights the upcoming AGM
- AGM update

 - At the AGM meeting, Board Chair will share about the request from the department in the draft service agreement of adding a community member at large. This will go to a vote for membership at the 2026 AGM.
 - No board elections this year.
 *Amendment A call for nominations for the mainland Mi'kmaq seat was sent out in early April.

- Policy committee update- met Feb. 27th, next meeting March 27th virtual.
- Compassion committee update developed a google referral form and presented it to the board
- Diversity committee, there was no update.

- It was noted that any proposed bylaw changes must be ready by April 30th to meet the 30 notice requirement for all foster caregivers as per our bylaws.
- Kinship foster caregivers serving on the board Had discussion around what this would potentially look like. Examined bylaw requirements to serve on the board. Will have further discussion next meeting.

- Board self-evaluation to be passed in at next board meeting.
- ED evaluation will be done at the AGM by the board chair.
